These funds are to be used for the replacement of the roof on the kitchen wing of the Old Meeting House as delineated in the CPA grant application filed in January 2013. Article 26: To see if the Town will vote to appropriate or reserve from the Community Preservation Fund, the amount of \$17,000.00 to the Granville Board of Selectmen. These funds are to be used for the replacement of the Town Green Walkway according to the plan submitted by the Town Green Committee in the CPA grant application filed in January 2013. Of these funds, \$7,000.00 is to be allocated from the Open Space Reserve sub-account and \$10,000.00 is to be allocated from the Undesignated Reserve sub-account. Sponsored by the Community Preservation Committee

Article 27: To see if the Town will vote to delete Section 4.3.2 (a) of the "Granville Zoning Bylaws as adopted May 1993 and retyped to incorporate amendments of May, 2008 and May, 2010" and replace it with the following proposed new Section 4.3.2 (a):

4.3.2 Floodplain district boundaries and base flood elevation and floodway data:

a. The Floodplain District is herein established as an overlay district. The District includes all special flood hazard areas within the Town of Granville designated as Zone A on Hampden County Flood Insurance Rate Map (FIRM) issued by the Federal Emergency Management Agency (FEMA) for the administration of the National Flood Insurance Program. The map panels of the Hampden County FIRM that are wholly or partially within the Town of Granville are panel numbers 25013C0140E, 25013C0144E, 25013C0145E, 25013C0326E, 25013C0328E, 25013C0330E, 25013C0335E, 25013C0336E, 25013C0337E, 25013C0345E, 25013C0352E, 25013C0354E, 25013C0355E,

25013C0361E, and 25013C0362E dated July 16, 2013. The exact boundaries of the District may be defined by the 100-year base flood elevations shown on the FIRM and further defined by the Hampden County Flood Insurance Study (FIS) report dated July 16, 2013. The FIRM and FIS report are incorporated herein by reference and are on file with the Town Clerk, Building Officials, and Conservation Commission. (Explanation: Current Section 4.3.2 (a) Floodplain district boundaries and base flood elevation data: The Floodplain District is herein established as an overlay district. The District includes all special flood hazard areas designated as Zone A on the Town of Granville Flood Hazard Boundary Map (FHBM) issued by the Federal Emergency Management Agency (FEMA) for the administration of the NFIP dated October 22, 1976. The map indicates the 100-year regulatory floodplain. The FHBM is incorporated herein by reference and is on file with the Town Clerk, Buildings Officials, and Conservation Commission)
