INFORMATION ON PERSONAL PROPERTY FORM OF LIST

Re: 2014 Personal Property Form of List

Under Massachusetts General Laws, owners of taxable personal property located in the Commonwealth on January first are required to provide the local Board of Assessors with a list of such property. Failure to submit a list loses the right to appeal the value the assessors place on your personal property.

Businesses not treated as a corporation for Federal tax purposes should include tools and equipment, machinery used in the conduct of business, and merchandise. Summarization is encouraged.

Second home owners should include household furniture & effects, unregistered vehicles, and lawn furnishings.

Mobile home owners should give the make, model and year of their mobile home.

Insurance inventories or other documents that list personal property can be submitted as an attachment to the form to simplify submittal.

OPEN BRUSH BURNING - NEW PROCEDURES

All open burning of brush in Massachusetts is regulated by The Massachusetts Air Pollution Control Regulation, 310 CMR 7.07. City and town fire departments are mandated to enforce these regulations on a local level. Pertinent parts of 310 CMR 7.07 are provided with all open burning permits. Please observe these rules and regulations

The 2014 season for open burning of brush is from January 15th thru April 30th. **Permits are available Monday thru Friday from 8am to 4pm by calling the fire department at 413-455-8527.**

Mass DEP has enacted a change in policy this year that we ask for your cooperation with:

Each morning you wish to burn you must first call the GFD at 413-455-8527 after 8am even if you already have a permit for that day to confirm that burning with a permit is allowed. (Burning hours are from 10am to 4pm) On weekends if no one is available to take your call a recorded message will be provided.

Mass DEP is providing all Massachusetts fire departments with daily authorization to issue open burning permits. The GFD staff is not able to authorize any burning before 8am on any day.

Permits remain free of charge and can be issued in advance of the effective date. If you wish to burn on a weekend you must obtain a permit during the week. When you call to request your permit we will fax or E-Mail it to you. If you do not have access to a fax machine or computer with E-Mail you may arrange to pick up your permit at the town hall during normal business hours.

We apologize for the inconvenience of this procedure. It places an additional burden on the GFD volunteers as well, but we are obligated to follow state mandates.

While burning brush please remember that for a brush fire that becomes unmanageable, or for any other fire emergency, calling 911 early is the best option. The GFD is equipped to quickly bring a fire under control before it spreads and grows in size.

Mema's Pet Safety Tips for the Winter Months

"As the harsh winter months settle in, it is important that you think about keeping your pets safe from all of the dangers that the season can present," states Massachusetts Emergency Management Agency, (MEMA) Director Kurt Schwartz. "Mema offers some tips to help insure your pet's safety." Do not leave your pet outdoors when the temperatures drop below freezing. Dogs need outdoor exercise, but take care not to keep them outdoors for lengthy periods of time during very cold weather. Pets that are mostly indoors need time to adapt to cold temperatures by building up a thicker coat and toughening their footpads for ice and snow. Short-coated dogs may feel more comfortable wearing a sweater during walks. Dogs and cats are safer indoors during all sorts of extreme weather. Care for your pet's feet. If your pet walks on salted or chemically treated areas, be sure to wash paws after your walk. Gently rub the bottom of the feet to remove these irritants as soon as your dog is off the road. Many dogs need boots in cold weather, regardless of their coat length. If your dog frequently lifts up its paws, whines or stops during walks, it may be demonstrating that its feet are uncomfortably cold.

Wind-chill is a threat to pets, even those protected by shelters. Outdoor dogs must be protected by a dry, draft-free doghouse that is large enough to allow the dog to both sit and lie down comfortably, but small enough to retain body heat. The floor should be elevated a few inches off the ground and covered with cedar shavings or straw. The entrance of the dog house should be turned to face away from prevailing winds, and the entrance should be covered with a flap of heavy waterproof fabric or heavy plastic.

Pets that spend a greater amount of time outdoors in the winter need more food.

Maintaining warmth depletes energy. Routinely

check your pet's water dish to ensure the water is fresh and not frozen. To prevent your pet's tongue from freezing to its feeding or drinking bowl, plastic, rather than metal food and water bowls are preferred.

Never leave a pet locked inside a car during extremely cold weather. Cars can actually act like a refrigerator, holding in cold air, putting your pet at risk. Be leery of frozen bodies of water. Always keep your pets on a leash when walking them near suspected frozen bodies of water. The ice may not be sturdy enough to support your pet. If a pet falls though the ice, do not attempt to rescue your pet yourself; call 9-1-1 or go for help.

Antifreeze and deicing chemicals can be hazardous. Many types of antifreeze have a sweet taste that can attract animals. Always store antifreeze out of reach and clean up spills. Antifreeze made with propylene glycol can actually be swallowed in small amounts and not injure pets, wildlife or humans.

Warm automobile engines are dangerous for cats and small wildlife. Parked vehicles can attract small animals, which may crawl under the hood seeking warmth. To avoid injuring hiding animals, bang on your car's hood to scare them off before starting your engine.

How can you tell if the Email is a hoax or urban legend?

Some messages are more suspicious than others, but be especially cautious if the message has any of the characteristics listed below. These characteristics are just guidelines—not every hoax or urban legend has these attributes, and some legitimate messages may have some of these characteristics:

It suggested tragic consequences for not performing some action

It promises money or gift certificates for performing some action

It offers instructions or attachments claiming to protect you from a virus that is undetected by anti-virus software

It claims it's not a hoax

There are multiple spelling or grammatical errors or the logic is contradictory

There is a statement urging you to forward the message

It has been forwarded multiple times (evident from the trail of email headers in the body of the message)

How to Obtain the Senior 'Circuit Breaker' Tax Credit

Dear Massachusetts Senior,

If you're a Massachusetts property owner and are age 65+, you'd probably welcome a break on your property taxes. Dream on, you say?

Actually, such an option exists and, if you're eligible, it's yours for the taking.

According to the MA Department of Revenue, some 957,000 residents 65 and older in the state are eligible to receive the tax credit.

It's called the Circuit Breaker, and according to this month's AARP Bulletin, in 2012, more than 86,000 Massachusetts taxpayers claimed nearly \$67 million in refunds under the program, according to the state Department of Revenue. The average refund in 2012 was \$774. The Circuit Breaker refund acts the way an electrical circuit breaker would work, but here it prevents property taxes from exceeding an older person's income and ability to pay taxes.

Eligible taxpayers can file for the credit up to three years retroactively, so read the Bulletin story today and learn more about this valuable tax refund.

YOU MAY QUALIFY FOR CASH or CREDIT FROM THE STATE IF YOU PAY RENT OR PROPERTY TAXES

The Massachusetts "CIRCUIT BREAKER" TAX PROGRAM is for persons 65 or over whose property taxes (or 25% of rent) exceed 10% of their annual gross income and who meet other qualifying criteria. You may be eligible even if you receive a property tax exemption through your city/town.

If you meet certain requirements, you may be eligible for the refundable tax credit or "Circuit Breaker" now and for the past three years* - even if you did not file Massachusetts state income tax forms. You may file for the 2013 tax year beginning in January 2014 and may file retroactively for the last 3 years*. The maximum credit you may receive for tax year 2013 is \$1030, 2012 is \$1000, 2011 is \$980, and for tax year 2010 is \$970.

Seniors must meet the following guidelines to qualify for the refund or credit

- 1. Age 65 or over by the end of the tax year for which you are filing
- 2. Income: includes Social Security, and other income not ordinarily taxed in Massachusetts

Income for tax year:	2010	2011	2012	2013
Single	51,000	52,000	53,000	55,000
Head of household	64,000	65,000	67,000	69,000
Married, filing jointly	77,000	78,000	80,000	82,000

- 3. Residency: Own or rent residential property in Massachusetts (primary residence) Public Housing and subsidized renters are not eligible.
- **4. Assessed valuation of home (must not be greater than)**For tax year: 2010 \$764,000 2011 \$729,000 2012 \$705,000 2013 \$700,000
- 5. 10% rule: For Owners: Amount by which property tax (plus 50% of water and sewer fees when not in property tax bill) exceeds 10% income, up to the maximum.

For Renters: Amount by which 25% of annual rental payments exceed 10% of total income, up to the maximum. The law assumes that 25% of rent goes toward property tax.

Even if you don't normally file with the state, if you meet the above criteria you are most likely due a "refund" check/tax credit from the Dept. of Revenue. If you have an accountant, ask him/her for help with this year and /or previous years.
