CORI Background Checks: A Sign of The Times

There are lots of things about the good old days that I recall fondly. I remember that growing up in Granville, the world felt very safe to me. I grew up on South Lane where my neighbors were, my uncle, my great aunt, and my grandparents. And I knew all of the rest of the neighbors by name and they knew me. In those days we didn't wear seat belts, our parents left us in the car when they shopped and we roamed far and wide during the day. It seemed that I couldn't get in trouble, even when I tried.

I remember one time my friends and I were working on a project at the library. We had strict instructions to stay at the library. However, we just could not resist sneaking over to Ma Stacker's for a candy bar. By the time we got home our 'crime' had been reported. We had been seen 'walking the streets' and someone gave my mother a call!

Things had changed a great deal by the time I was raising my own three kids. I could not imagine letting my own kids roam as we did. I no longer knew my neighbors. And the headlines began to horrify every parent. Places we had considered safe turned out not to be safe after all, as the abuse of children came to light in just about every arena. Maybe we had been too trusting?

That brings us to the present day. In response to reported abuses schools, civic organizations, and churches now require background checks. At first these were required of people working with children, now they have been extended to include those working with the elderly or with those facing physical and mental challenges. In my day job, as a pastor, I am required to have an even more extensive background check that is renewed periodically. Along with most churches, we have adopted a safe sanctuary policy requiring our Sunday School teachers to have background checks

You would not be alone if you felt that this requirement is intrusive and even insulting. Here

you are volunteering your time and wanting to do something good for others—and yet a background check is required? It is also awkward for those of us leading organizations. On the one hand we are desperate for volunteers and on the other hand standing before us are generous volunteers, some of whom we have known forever, and yet we are required by law to initiate the background checks. However, if a background check, saves just one child or elderly person from being abused, this sign of the times, is worth the trouble. Thanks, though, for your understanding and patience. Community Outreach Worker: Granville Council on Aging

What is a CORI?

A CORI is a check for <u>Criminal Offender Record</u> Information.

Why is a CORI background check required for Council on Aging Volunteers? What is the purpose of the CORI check?

Massachusetts state law requires CORI checks for employees of programs that serve children (M.G.L., Chapter 6). State law was expanded in November 2002 to include:

Employees and volunteers providing services to elderly or disabled persons in a home or community-based setting (Section 172C) These must be renewed every two years.

The purpose is to ensure that those who work with vulnerable groups do not pose a risk to others.

For whom is the CORI check requested?

CORI checks are completed for: All current and prospective employees and volunteers providing services to elderly or disabled people in their homes or in community-based settings.

What information does a CORI request?

The CORI request provides access to conviction and pending court activity data. CORI applies only to crimes punishable by incarceration. It does not include civil matters, acquittals, or accusations that were dismissed. The intent is not to cause harm or public embarrassment to people for past mistakes that they have already been punished for.

How is CORI information requested?

Individuals fill out the "CORI Request Form" and return them to George Reichert: Coordinator II; Southern Hilltown COA Consortium who submits the information to the Criminal History Systems Board for processing.

Who receives and reads the results of the CORI check?

A person authorized under the CORI Act and certified by the Criminal History Systems Board receives and reads the results. The Criminal History Systems Board has authorized George Reichert. CORI results may be shared with the applicant to whom it pertains.

What will happen if there is an offense on record?

The Criminal History Systems Board (CHSB) has developed a list of offenses considered "Lifetime Disqualifications." People with these offenses are disqualified from working or volunteering with vulnerable populations.

Is the CORI confidential?

Yes. Dissemination of CORI results to any unauthorized party may subject the offending agency or individual to a fine of \$5,000 and/or up to one year in jail, in addition to other civil penalties. CORIs are secured in a locked file.

I had a CORI check done for a different organization. Why do I need another?

A CORI result does not transfer from one organization to another. Each agency must complete its own CORI check on an individual. Due to the confidential nature of the CORI process, agencies are not permitted to share the results of CORI checks.

VETERANS TAX EXEMPTIONS

<u>CLAUSES 22, 22A, 22B,22C, 22D, 22E AND PARAPLEGIC</u>

WHAT ARE TAX EXEMPTION CLAUSES 22, 22A, 22B,22C, 22D, AND 22E?

Tax exemption clauses 22, 22A, 22B, 22C, 22D, and 22E release an individual from the requirement to pay all or a fraction of the taxes assessed on their real property. These clauses provide exemptions from \$400.00 up to \$2,500.00 for qualified veterans and their spouses (or surviving spouses). Surviving spouses of veterans entitled to exemptions under 22, 22A, 22B, 22C, 22E and paraplegics will continue to receive the full exemption, even if they remarry.

WHO IS ELIGIBLE?

Disabled veterans and their spouses (or surviving spouses) are eligible provided they meet predetermined qualifications. Also eligible are veterans who were awarded the Purple Heart, Gold Star Parents, and veterans who have been awarded the Congressional Medal of Honor, Distinguished Service Cross, Navy Cross or Air Force Cross. Please contact your local Board of Assessors for eligibility prerequisites.

WHAT ARE THE REQUIREMENTS?

Applicant must have been residing in

Massachusetts for at least six months before entering the service or have lived in the Commonwealth for at least 5 years before filing for the exemption. The veteran must own and occupy the property in whole or in part as his or her domicile on July 1 of the tax year.

Please note: Individual communities may adopt a shorter qualifying residency requirement. Contact your local Assessor's Office for more information.

ARE PARAPLEGIC VETERANS ELIGIBLE FOR AN EXEMPTION?

A total exemption is available to paraplegic veterans and their surviving spouses, even if they remarry. The veteran must be certified by the Veteran's Administration as paraplegic.

HOW DOES ONE APPLY?

Application must be filed annually with the local Assessor's Office in your city or town on or before December 15 or within three months after the actual bill is moiled, whichever is later. If there are any questions, please contact your local Board of Assessors.

CAN A DECISION BE APPEALED?

If the application for exemption is denied, the applicant may appeal in writing to the State Appellate Tax Board, 100 Cambridge Street Ste. 200, Boston, MA, 021 14, or call (61 7) 727-31 00, or visit their website at: www.moss.gov/atb.



ELDERLY AND HARDSHIP TAX DEFERRALS

WHAT IS A TAX DEFERRAL?

A tax deferral permits one to defer payment on property taxes. As opposed to an exemption, these deferred taxes must eventually be paid. Below are the two types of deferrals currently available: Clause 41A for seniors and Clause 18A for taxpayers of any age with financial hardships.

CLAUSE 41A

Under Clause 41A, one enters into on agreement with the local assessor to defer payment of all or part of the taxes plus 8% interest until that deferred tax and interest reaches 50% of the property value.

WHO IS ELIGIBLE?

Applicants must be 65 years and occupy as a domicile the property on which the taxes are being deferred, or be joint owners with a spouse or another person(s).

WHAT ARE THE REQUIREMENTS?

Applicant must have owned and occupied any real estate property in Massachusetts for 5 years.

Applicant must have resided in Massachusetts for the preceding 10 years.

Applicant must have income which does not exceed \$20,000 in the calendar year preceding the year of application

Please note: A community may adopt a higher maximum qualifying income that shall not exceed \$40,000.

CLAUSE 18A

Under Clause 18A, assessors may grant taxpayers experiencing financial difficulties a temporary tax deferral. The taxpayer may be of any age and the hardship may be due to any number of reasons, including a change to active military status. Assessors have the discretion to establish specific criteria for determining whether a taxpaver meets the statutory standard of financial hardship. It can be granted for a maximum of three consecutive years. After the end of that period, the deferred taxes must be paid. The taxpayer may pay the deferred taxes, plus interest, in annual installments over a five-year period. The first payment is due two years after the last year of the deferral. For more information or an application, please call your local assessor's office.

HOW DOES ONE APPLY FOR A TAX DEFERRAL?

Contact your local Board of Assessors for an application.

Clause 41A can be used in conjunction with an exemption for which an individual qualifies.

Applications under Clause 41A must be filed with the local Board of Assessors on or before

December 15 each year or within three months from the mailing of the actual tax bill.

CAN A DECISION BE APPEALED?

If the application for tax deferral is denied, the applicant may appeal in writing to the State Appellate Tax Board, 100 Cambridge Street Ste. 200, Boston, MA, 021 14, or call (61 7) 727-3100, or visit their website at: www.

ELDERLY TAX EXEMPTIONS CLAUSES 41,41B AND 41C

WHAT ARE TAX EXEMPTION CLAUSES 41,41B and 41C?

A tax exemption releases an individual from the requirement to pay all or a fraction of the taxes assessed on his/her personal or real property. Clause 41 benefits persons seventy (70) years of age or older. It provides the greatest benefit, a deduction of \$500 from the year's tax bill. Clause 41 B or 41 C exemptions have broader allowances for total assets and income. Also, under local option Clause 41 D, communities may increase their income and asset limits annually by a cost-of-living adjustment established by the Department of Revenue.

Individual cities or towns must adopt the legislation that provides for the exemption under Clause 4'1 B or 41C.

WHO IS ELIGIBLE?

Senior citizen homeowners are eligible for the tax exemption under Clause 41,41B or 41C.

WHAT ARE THE REQUIREMENTS?

Applicant must be 70 years or older prior to the year that the exemption is being filed, as well as own either all or part of the property that is being assessed.

Applicant must have owned and occupied real estate property in Massachusetts for five years.

The applicant has been domiciled in Massachusetts for the preceding 10 years.

Surviving spouses who inherit such property filing must have occupied the property for 5 years.

Please Note: In addition to requirements listed above, Clause 41,4'1 B, and 41 C have several limitations. The local Assessor's Office can provide an individual with further information regarding the requirements for the exemption clause being used in the local city or town.

HOW DOES ONE APPLY?

Applications must be filed annually with the local assessor's office in the applicant's city or town and are due within three months after the mailing of the actual tax bill.

CAN A DECISION BE APPEALED?

If the application is denied, applicant may appeal in writing to the State Appellate Tax Board, 100

Cambridge Street Ste. 200, Boston, MA, 021 14, or call (61 7) 727-31 00, or visit their website at: www.moss.gov/otb.

CLAUSES 17,17C, 17C1/2 AND 17D

WHAT ARE TAX EXEMPTION CLAUSES 17,17C, 17C1/2 and 17D?

Tax exemption clauses 17, 17C, 17C1/2 and 17D release an individual from the requirement to pay all or a fraction of the taxes assessed on real property. There are no income limitations for tax exemptions filed under Clause 17.

WHO IS ELIGIBLE?

Clause 17 exemptions are available to surviving spouses, a minor whose parent is deceased, or persons over seventy (70) years of age.

WHAT ARE THE REQUIREMENTS?

Applicant must be seventy (70) years or older and have owned and occupied the property in Massachusetts for no less than ten years (clause 17, 1 7C, and 17C1/2) or no less than 5 years (clause 17D).

Surviving spouse or any minor whose parent is deceased who occupies the residence as their domicile.

Clause 17, 17C, 17C1/2 and 17D have real estate and personal property tax requirements that may vary from community to community depending on local acceptance. Contact your local Assessor's Office for information on the conditions that apply.

HOW DOES ONE APPLY?

Contact the local Board of Assessors for an application form. One must apply each year for an exemption. Generally, an applicant can receive only one exemption, so submit the application for the exemption which will provide the greatest benefit.

Applications under Clause 17,17C, 17C1/2 and 17D must be filed with the local Board of Assessors on or before December 15 of each year or within three months from the mailing of the actual tax bill.

CAN A DECISION BE APPEALED?

If the application is denied, applicant may appeal in writing to the State Appellate Tax Board, 11 00 Cambridge Street Ste. 200, Boston, MA, 021 14, (61 7) 727-31 00, or visit their website at: www.mass.gov/atb/.
