We had an encouraging response from folks who are willing to be part of a test run of the "Granville Buddy Program."





JOB DESCRIPTION Granville Public Library Library Director

JOB SUMMARY:

The Library Director is responsible for the direction, operation, and oversight of the library in concert with the Board of Trustees and in conformity with applicable State and Federal Law, while envisioning community needs and promoting community engagement. The Library Director builds community relations and, with the Board of Trustees, is the liaison and key communicator among other town departments, including, but not limited to Town Administrator, Director of Public Works and Schools, as well as the Granville business community. In keeping with the mission of the Library, the Library Director is responsible for maintaining an appropriate library collection. The Library Director is responsible for all other Library staff, as well as their supervision. The Library Director coordinates with the Trustees to submit a yearly budget to the town that addresses the needs of the community, advocates on behalf of the Library and. If necessary and available, the Library Director researches and applies for grant funding that supports the Library Mission.

SUPERVISION:

The Library Director reports to the Board of Trustees and is evaluated yearly on or around their hiring anniversary.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

As in all positions at the Granville Public Library, the Library Director's position requires flexibility and excellent use of time management. The Library Director's responsibilities include the same as all staff when working during open library hours. This includes working as a circulation librarian, preparing books and media for cataloging, assisting patrons and providing check-in and check-out responsibilities. The Library Director, in collaboration with appointed staff, evaluates, obtains and weeds all materials, including books, media, and other things for the Library Collection and is responsible for the cataloging of all the items purchased for this collection. In addition to the maintenance of the Library Collection, the Library Director will support the acquisition of up-to-date technology hardware and software, necessary maintenance and website and social media updates and/or oversight. This position is responsible for collecting, analyzing, and reporting statistics to the Library Trustees bimonthly and to recommend improvements to help meet Community needs and improve community engagement. The Library Director is responsible for outreach including connecting with the community and schools, to create and foster the relationship between the community and the Library, as well to acquire adequate funding through town budget and grants opportunities.

ADDITIONAL RESPONSIBILITIES OF THE LIBRARY DIRECTOR:

- Develop and assign responsibility to staff, as well as the scope of duties.
- Supervise and evaluate employee performance and make recommendations.
- Manage approved budgets and oversee the maintenance of financial records.
- Complete yearly ARIS and Mass State Aid Reports, in addition to coordinating any report request for or by the Board of Trustees or the Library Club.
- Work with the trustees to prepare both short and long-range strategic plans for the library.
- Create, evaluate and submit book lists and reviews and pertinent information for the library's weekly Wowbrary Email blast and the Monthly Granville Caller Newsletter
- Update library technology for program and patron use.
- Research, write and manage grants, including, but not limited to LSTA, ALA, ARSL, MBLC grants.
- Maintain and develop knowledge of library procedures and activities and relevant State and Federal Laws by participating in appropriate in-service training and regional programs.

EDUCATIONAL AND PRIOR WORK EXPERIENCE:

Required:

A Bachelor's degree or equivalent experience Experience working with children and families. Demonstrated interest in Public Library service.

Preferred

A.L.A. accredited M.L.S. with 1-2 years of library experience preferred; or 2-4 years of supervisory experience in the library field.

SPECIAL KNOWLEDGE/ABILITIES FOR POSITION:

- Strong interpersonal communication skills with children, adults, and other libraries are necessary in this position.
- Basic to moderate level of financial bookkeeping and accounting, with computer skills
- Strong supervisory/managerial skills
- A high degree of motivation and initiative; work independently
- Strong multi-level oral and written communication skills

ANTICIPATED WEEKLY HOURS AND PAY RATE:

Hours: 12-17 @ \$20-\$25 Hours and Pay rate are Board of Trustee Recommendations

PHYSICAL REQUIREMENTS:

The occupant of this position must spend several hours a day walking, standing, and sitting. Activities include moderate to frequent physical exertion in body movement such as reaching, bending, and twisting. The position also requires moderate to frequent grasping, pulling, and pushing of materials as well as fine manipulation associated with the required use of a computer, keyboard, and calculator. The Library Director must also be able to lift and move objects up to twenty (20) pounds on a frequent basis.

ENVIRONMENTAL CONDITIONS:

The Library director works predominantly indoors, but outdoor activities will be expected during seasonally appropriate weather. Winter Hours may require periodic sanding/salting of walkways and stairs. Covid cleaning procedures are required. The regular solvents are adhesives such as rubber cement and cleaning solutions.



Representative Boldyga supports comprehensive \$1.02 billion tax relief package

Reforms estate tax, expands Senior Circuit Breaker and rental deduction

BOSTON – State Representative Nick Boldyga (R-Southwick) has joined with his colleagues to approve a comprehensive tax package that will provide significant financial relief to Massachusetts residents and businesses, but he believes more needs to be done to ease the burden on taxpayers and small businesses to make Massachusetts a more affordable place to live.

House Bill 4104, An Act to improve the Commonwealth's competitiveness, affordability, and equity, offers a phased-in approach to a series of tax reforms that is expected to produce \$561 million in savings for taxpayers this fiscal year and an estimated \$1.02 billion in savings once the changes are fully implemented in 2026. The bill, which represents a compromise negotiated over the last three months by a six-member conference committee, received preliminary approval by the House of Representatives on a vote of 155-1 on September 27.

Representative Boldyga emphasized the importance of this tax relief package while expressing his belief that it should be just the start of broader efforts to reduce wasteful spending and further alleviate the tax burden on those struggling to make ends meet. He said, "While this is a step in the right direction, we must recognize that more needs to be done to ensure that the hardworking people of our Commonwealth get the relief they deserve. We must find ways to reduce wasteful spending and provide additional tax relief."

The final tax package provides several key benefits, including increases in the child and dependent tax credit, the rental deduction cap, and the Earned Income Tax Credit. It also doubles the Senior Circuit Breaker tax credit while raising the estate tax threshold from \$1 million to \$2 million and increasing the amount seniors can deduct from their property taxes when participating in the Senior Property Tax Volunteer Program.

House Bill 4104 also authorizes a reduction in the short-term capital gains tax rate and implements a single sales factor for companies beginning January 1, 2025, to encourage economic growth and help maintain Massachusetts-based businesses. In addition, the bill triples the maximum allowable Title V tax credit for homeowners repairing or replacing their septic tanks, while also expanding the lead paint abatement and taking steps to promote more housing development across the state.

According to Representative Boldyga, House Bill 4104:

• Combines the child and dependent tax credits into one while eliminating the existing cap and increasing the credit from \$180 to \$310 in FY23 and to \$440 in FY24, which will benefit over 565,000 families;

• Increases the rental deduction cap from \$3,000 to \$4,000, which will assist approximately 800,000 renters;

• Raises the Earned Income Tax Credit from 30% to 40% of the federal credit, which will benefit approximately 400,000 taxpayers earning less than \$60,000;

• Doubles the maximum Senior Circuit Breaker tax credit from \$1,200 to \$2,400, indexed to inflation, to assist nearly 100,000 seniors with their housing costs;

• Eliminates the estate tax for all estates valued under \$2 million and allows for a uniform credit of \$99,600, effective January 1, 2023;

• Allows municipalities to provide up to \$2,000 in property tax reductions for older residents participating in the senior work-off program, which is currently capped at \$1,500;

• Reduces the tax on short-term capital gains from 12% to 8.5%;

• Replaces the current three-prong sales tax apportionment for Massachusetts-headquartered businesses that incorporates property, payroll and sales with a new system that only factors in sales;

• Increases the maximum tax credit for septic tank repairs or replacement under Title V from \$6,000 to \$18,000 and also increases the amount that can be claimed to \$4,000 per year;

• Doubles the lead paint abatement to \$1,000 for partial abatement and \$3,000 for full abatement;

• Allows cities and towns to adopt a local property tax exemption for renters whose income falls below a certain level set by the community;

• Increases the statewide cap on the Dairy Tax Credit from \$6 million to \$8 million to assist local farmers impacted by reductions in milk prices;

• Exempts employer student loan payments from being counted as taxable income by the state; and

• Increases the maximum amount of alcohol that hard ciders and still wines may contain from 6% of alcohol by weight to 8.5%, which will allow more of these locally produced products to be taxed at a lower rate.

House Bill 4104 must still be approved by the Senate and enacted in both branches before reaching Governor Maura Healey's desk for her review and signature.
