(# of payments remaining 1, principal balance due \$20,000.00) TRANSFER FROM FREE CASH RECOMMENDED BY THE FINANCE COMMITTEE

**Article 15**: To see if the Town will vote to raise and appropriate, transfer from available funds, borrow or otherwise provide \$300,000.00 to purchase and equip a new DPW plow truck, including all incidental and related costs; or take any other action relative thereto.

- **Article 17:** To see if the Town will vote to raise and appropriate, transfer from available funds, or borrow the sum of \$25,000.00 to fund additional tree cutting and the removal of hazardous, dead and/or diseased trees, including all incidental and related costs; said funds to be appropriated to the Department of Public Works Tree Maintenance Account; or to take any action relative hereto. TRANSFER FROM FREE CASH RECOMMENDED BY THE FINANCE COMMITTEE
- **Article 18:** To see if the Town will vote to raise and appropriate, transfer from available funds, or borrow the sum of \$9,000.00, which appropriation hereunder shall serve as the Town's 5% share for a Assistance to Firefighters Grant through FEMA, for the purchase of replacement radio equipment, including all incidental and related costs; or to take any action relative hereto. TRANSFER FROM FREE CASH RECOMMENDED BY THE FINANCE COMMITTEE
- **Article 19:** To see if the Town will vote to raise and appropriate, transfer from available funds, or borrow the sum of \$50,000.00 for the design and construction of renovations to the West Granville Firehouse, including all incidental and related costs; or to take any action relative hereto. BORROWING RECOMMENDED BY THE FINANCE COMMITTEE, 2/3 vote required.
- Article 20: To see if the Town will vote to raise and appropriate, transfer from available funds, or otherwise provide \$30,000.00 to fund training for the officers of the Granville Police Department, including state mandated MPTC Bridge Academy training and all incidental and related costs; or to take any action relative hereto.

- **Article 21:** To see if the Town will vote to raise and appropriate, transfer from available funds, or borrow the sum of \$175,642.00 to fund payment of the unused accrued benefits that a retiring Town of Granville employee is entitled to receive; or to take any action relative hereto. RAISE AND APPROPRIATE RECOMMENDED BY THE FINANCE COMMITTEE
- Article 22: To see if the Town will vote to accept the provisions of Section 7A of MGL Chapter 32B, allowing the Selectboard to increase the Town's share above fifty percent of the premium for contributory group and life insurance for employees in the service of the Town and their dependents, or take any other action relative thereto.
- Article 23: To see if the Town will vote to accept the provisions of Section 9E of MGL Chapter 32B, allowing the Selectboard to increase the Town's share above fifty percent of the premium for contributory life, hospital, surgical, medical, dental and other health insurance for employees retired from the service of the Town, and their dependents, or take any other action relative thereto.
