EVERSOURCE requests permission to locate a line of poles, wires, cables and fixtures, including the necessary sustaining and protecting fixtures along and across the following public way:

584 SOUTH LANE

EVERSOURCE IS REQUESTING PERMISSION TO INSTALL (4) NEW POLES. THE (2) NORTHERN MOST POLES NEED TO BE MOVED ACROSS THE STREET RESPECTFULLY TO CREATE A STRAIGHT LINE FOR OUR INFRASTRUCTURE. THE SOUTHERN 2 POLES ARE NEW INSTALLS TO ACCOMMODATE A NEW RESIDENT OF THE TOWN THAT IS BUILDING A NEW HOME.

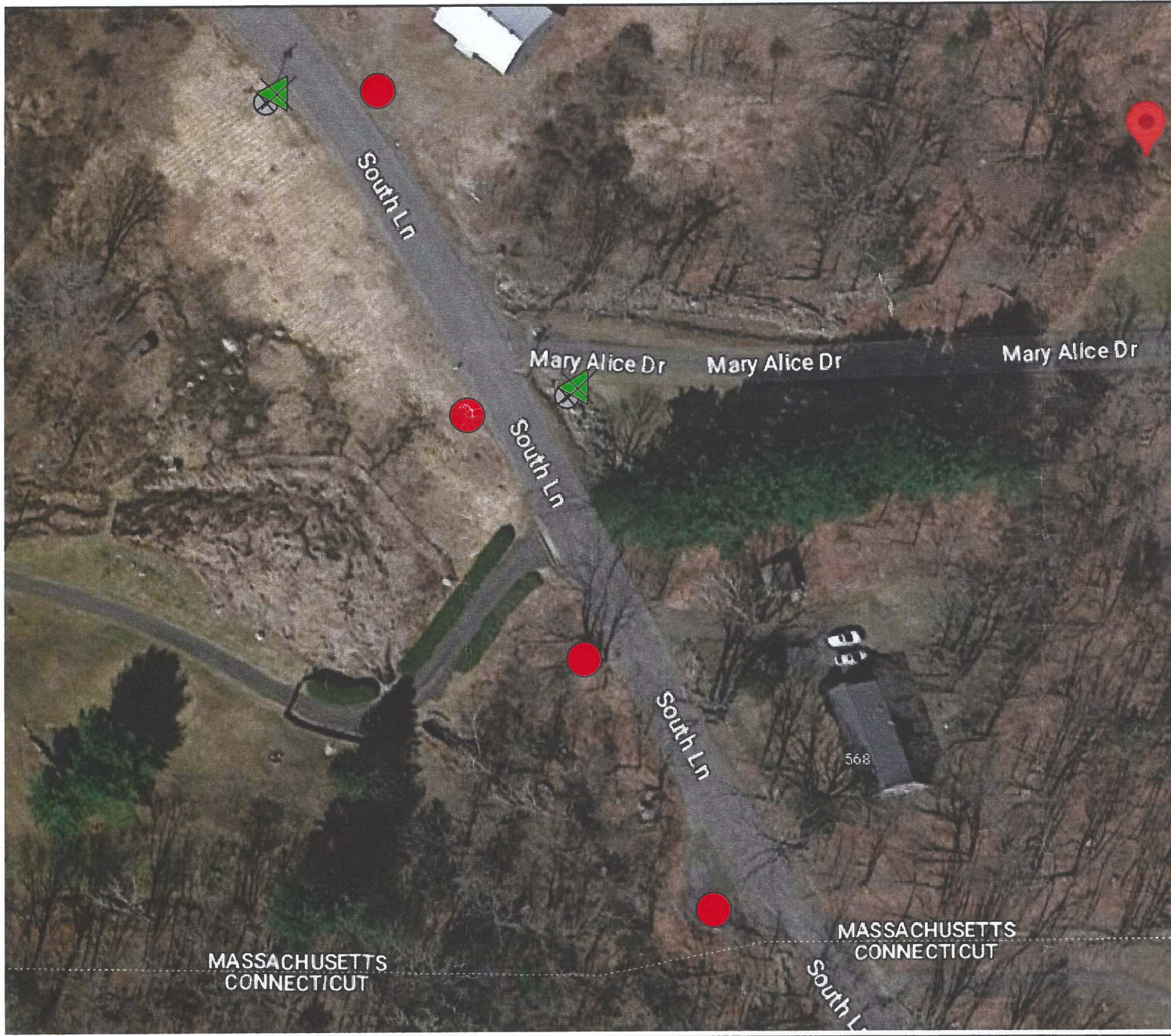

ORDER FOR POLE LOCATIONS

By the Selectboard of the Town of Granville, Massachusetts.

Notice having been given and a public hearing held, as provided by law,
IT IS HEREBY ORDERED:

That the EVERSOURCE ENERGY be and it is hereby granted a location for and permission to construct and maintain a line of poles wires and cables together with such sustaining and protecting fixtures as said Company may deem necessary, in the public way hereinafter referred to as requested in petition of said Company dated the 25th day of May, 2023.

All construction under this order shall be in accordance with the following conditions:

Poles shall be of sound timber, and reasonably straight, and shall be set substantially at the points indicated upon the plan marked ~~80446191~~ filed with and made a part of said petition. There may be attached to said poles not to exceed 18 wires and 2 cables and all of said wires and cables shall be placed at a height of not less than 18 feet from the ground. **PLAN #8045913**

The following is the public way along which the poles above referred to may be erected, and the number of poles which may be erected thereon under this order:

Location: 584 South Lane, Granville, MA.

Reason: EVERSOURCE is requesting permission to install ⁽²⁾~~(4)~~ new poles. ~~The (2) northern most poles need to be moved across the street respectfully to create a straight line for our infrastructure.~~ The southern 2 poles are new installs to accommodate a new resident of the town that is building a new home, **as far off the road from the center line, and the southern most as close to state line per DPW.**

Also that permission be and thereby is granted to said EVERSOURCE to lay and maintain underground laterals, cables and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as it may desire for distributing purposes.
