Woodlands Cemetery Update and History

Keep the faith; Spring is coming to Granville...eventually.

The GPS projects for Northeast and Main Rd cemeteries have been completed. All known graves in each of those two cemeteries are documented along with the GPS coordinates of each grave and a picture of the headstone. In addition,

the immediate families for each deceased is identified. These are available online on the Granville Historic Image Library.

Of all the people in Woodlands Cemetery, Daniel (Elihu) Spelman was the earliest born. July 12, 1738. He had 11 siblings. According to the Spelman Genealogy, Daniel married Mary Carpenter and spent a great deal of his life as a soldier...including the French and Indian War and the Revolution. His rank in the Revolutionary War



was that of Drum Major. Drums were crucial in battlefield communications from the officers to the troops. It is assumed that, as in the war of 1812, a drum major's only weapon was a sword. The published family Genealogy says that Daniel's sword was in the possession of his descendants. Perhaps it still is. Daniel lived to age 90 and is buried in Woodlands Cemetery.

Daniel had a sister Elizabeth (1740-1836), married to Samuel Bancroft Jr. Her

descendants speak of her: →

Back in the day when almost no one commuted daily out of town to make a living, life consisted of town, neighbors and family. If a spouse died at an early age, remarriage was rather customary. Daniel had an older brother, Aaron (1733-1821). Aaron owned a home at 275 South Lane and was married 3 times. He first married Elizabeth, the sister of Justus Rose. Elizabeth died at age 61. Aaron then married Deborah. the widow of the same Justus Rose. Back when Deborah was married to Justus, they had a daughter also named Deborah. Daughter Deborah married Aaron's younger brother Stephen. Aaron and his wife Deborah (the mother) were, at the

Elizabeth (Spelman) Bancroft was one of the most estimable members of the Spelman family, and we may look back upon her record as one typical of all that is most admirable in those traits of character which our Puritan grandmothers possessed, and which every true American must reverence. She lived to the grand old age of ninety-six years, her life having been set in stirring times. She saw her husband, son, and other near relatives depart from the quiet mountain town of Granville to brave the perils of war in the struggle for the independence of the Colonies. Serene, faithful, and unshaken in her devotion to her family, she walked in the "even tenor" of her tranquil ways, rearing her family of nine children, and "training them in the way they should go." She was a woman of great piety, and had a wonderful influence over her own immediate family, and upon her friends and neighbors.

Her grandson, Mr. Ashley A. Bancroft of San Francisco, wrote of her: "I remember her slightly. She was of medium size, a devoted Christian, and highly esteemed by those who knew her. She lived to a great age, retaining her faculties to the last."

Her son, Azariah, wrote: "She was a woman of great endurance, though slender, and had a faculty for accomplishing work which was a marvel. She did not possess great physical force, but managed to accomplish no inconsiderable amount in rearing a large family and providing for their temporal and spiritual wants, clothing them, according to the custom of the time, with the wool and flax of her own spinning. The raw material entered the house from the farm and never left it except as warm durable garments upon the backs of its inmates.

same time, step-father and mother, uncle and aunt, brother and sister-in-law to Stephen and Deborah (the daughter)....who, by the way, had 12 children.

Aaron had a son, Elijah (1766 - 1846), buried in Woodlands. Elijah was a Deacon of the church and had 13 children with his first wife, Mary Chapman, and 4 children with his second wife, Temperance Bailey, who brought with her to this marriage 6 stepchildren. His third wife, Jemima Winchell, brought 8 stepchildren, totaling 31. It isn't known how many children were living at home at any one time but it suffices to assume that it was a busy household much of the time.

The extended Spelman family came to Granville from Durham and Middletown, CT, most in the mid 1700's. Their individual families were large and over time occupied numerous homes in

Granville. In addition to Aaron's home on South Lane, there were two Spelman houses originally on the town green. Those two, both in somewhat poor condition, were demolished in 1996 making way for "Citizens' Park", our town green.

Annual Census

The Town Clerk's Office has sent out the 2020 Annual Census forms. If you have your mail sent to a post office box and did not receive a form, call or stop in for a form to complete.

Annual Dog Licenses

The census package also included a dog license application for dog owners on record. All dogs that are six months of age or older must be licensed annually under M.G.L. Ch. 140. An updated proof of

rabies vaccination is required prior to licensing as well as proof of spaying and neutering. Incomplete applications will be returned to the sender.

Marriage Intentions

If you wish to marry, you can contact my office or any other Town Clerk in the Commonwealth. The first document that the couple must complete is the Marriage Intentions Form and both must be present at the same time to do so. Following this, a license is issued and you can be married any place in the Commonwealth. Your marriage license is filed at the Town Clerk's Office where the Marriage Intentions Form is completed. Notary Public

The Town Clerk, as well as the Town Administrator/ Matt Streeter are Notaries Public. If you need our services, please call either of us and make an appointment. The service is free of charge to Granville residents. Please note Notary Services are provided as a courtesy.

A Notary does NOT give legal advice.

The following are REQUIRED in order to be provided with Notary Services:

- The document CANNOT already have been signed
- All signers MUST be PRESENT at time of notarizing
- The Notary is stating they have WITNESSED the document being signed
- The person(s) signing MUST provide a proper photo ID
- The document MUST contain the appropriate Notarial Statement (Clause) - NO EXCEPTIONS ...
 Types of Notary: Jurat (statements are true) OR Acknowledgement (ones free act). The certificate MUST contain the oath given by notary to identify the type of notary act.

We do not notarize copies of original documents - NO EXCEPTIONS

We reserve the right to deny notarial services based on circumstances i.e., if the above-mentioned policies are not followed, documents are incomplete, documents are in a format that is unacceptable to this office or if the documents do not have the notarial clause/statement.

- Any license obtained after May 1 will be assessed a late fee of \$20.
- You may purchase a dog license that expires the same year as your rabies certificate. The expiration date must be at least three (3) months into the licensing year.
- Spayed/Neutered \$10.00
- Unaltered Dog \$15.00

Clothes Dryer Safety

In 2017, there were 100 dryer fires that caused civilian injuries, eight fire service injuries, and \$2.7 million dollars in property damage. Almost half of the fires, 47%, occurred in 1- and 2-family homes.

Clean the Lint Filter After Every Load

Remember to clean the dryer filter screen after each load of laundry, to clean the outside vents twice a year and to occasionally vacuum the motor area of the dryer. If materials such as cooking oil, solvents and other combustible or flammable liquids were not removed completely during the laundry cycle, heat from the dryer may cause them to ignite. This is the reason that mop heads should not be put into the dryer. An adult should be at home whenever the dryer is in use and the home should have working smoke alarms.

Dryer Fires Prevention Tips At-A-Glance:

- Clean the filter screen after each load to prevent lint buildup, which can cause fires.
- Stay home when the dryer is in use.
- Clean the outside vents twice a year to clean out any accumulated dust and lint.
- Vacuum the motor area. The dust and lint in the vent area can ignite if it gets hot. You may need to remove a panel in order to get to the motor area.
- Commercial dryers should be cleaned out regularly because of their frequent use and shared venting system.

- Don't dry mop heads in the dryer! The dryer's heat can ignite the chemical residue on mop heads.
- Keep the surrounding area clean. The dryer's heat may ignite anything left too close to the dryer.

Together, we can improve the life safety and well-being of our Granville residents!
