PETITION FOR POLE LOCATIONS

To the Selectboard of the Town of Granville, Massachusetts

GRANVILLE FIRE DEPARTMENT AND TOWN OF GRANVILLE request permission to locate a poles and fixtures, including the necessary sustaining and protecting fixtures along and across the following public way:

WEST HARTLAND ROAD (AKA STATE FOREST ROAD)


As fire chief and emergency management director I am requesting permission to install a municipally owned utility pole (marked in the sketch attached) for emergency services radio and communications equipment intended for infrastructure and transmission reliability improvement starting at approximately 1580' south of the centerline of intersection of West Hartland Road with Hunt Road and approximately 22' east of the centerline of West Hartland Road within the Town Right-of-Way in the vicinity and proximity of 326 West Hartland Road on the Granville Board of Assessors "911 Map for Addresses."

Wherefore that after due notice and hearing as provided by law, it shall be granted location for and permission to construct and maintain a pole, together with such sustaining and protecting fixtures as they may find necessary, said pole to be erected substantially in accordance with the plan filed herewith and made a part hereof below sketch.

ORDER FOR TOWN OWNER POLE LOCATION(S)

By the Selectboard of the Town of Granville, Massachusetts.

Notice having been given and a public hearing held, as provided by law, IT IS HEREBY ORDERED:

That the TOWN OF GRANVILLE and GRANVILLE FIRE DEPARTMENT be and they are hereby granted a joint location for and permission to construct and maintain a pole, together with such sustaining and protecting fixtures as said municipal entities may deem necessary, in the public way herein-after referred to, as requested in petition of said municipal entities dated the 11TH day of April 2024.

All construction under this order shall be in accordance with the following conditions:

Poles should be of sound timber, and reasonably straight, and shall be set substantially at the point indicated upon the plan marked Drawing **# 2024-01**, filed with and made a part of said petition. There may be attached to said poles future cable and wires; all of said wires and cables shall be placed at a height of not less than 18 feet from the ground at highway crossings, and not less than 8 feet from the ground elsewhere.

The following is the public way along which the poles above referred to may be erected, and the number of poles which may be erected thereon under this order:

WEST HARTLAND RD
